I. Call to Order

Chairman Schultheis called the meeting to order at 9:20am AK time.

b. Approval of Agenda

Enlow moved to approve agenda. Erickson seconded. All were in favor. Motion passed unanimously.

c. Approval of minutes from October 1, 2020

Chairman Schultheis requested motion to approve minutes.

Enlow moved to approve the minutes from October 1, 2020. Vice Chairman Kimball seconded. All were in favor. Motion passed unanimously.

d. Chairman's Remarks

Chairman Schultheis reviewed the day's agenda items.

e. Executive Director Update

Chairman Schultheis invited Executive Director Woodrow to give his report.

Woodrow reviewed upcoming All Hands on Deck dates and online platform

i. Antitrust Statement

Woodrow read the Antitrust Statement for the record.

I. New Business

a. ASMI BOD Roundtable: 5-minute update from each ASMI Board Director on market concerns, impacts, or areas ASMI staff should give attention in marketing initiatives

Chairman Schultheis began roundtable, inviting Vice Chairman Kimball to present first.

Vice Chairman Kimball noted ongoing COVID concerns going into coming season with continuation of prevention plans. Reviewed other markets, noting lockdowns in areas of Europe related to resurgence of wave of COVID. Noted calmer domestic market at present. Reviewed no major changes at present in Japanese market. Reviewed concerns related to shipping delays in China. Noted low harvest of pollock; focus on marketing of ground fish. Remarked on ongoing importance of marketing of wild salmon in relation to competition of farmed salmon.

Chairman Schultheis invited Palmer to present.

Palmer began report noting increase of foodservice. Noted connection to areas of growth in markets that lean towards access to outdoor activities. Noted strong movement in salmon market, roe market and canned salmon. Palmer also noted the importance of the industry being prepared for next year in relation to COVID prevention, especially related to ongoing screening and prevention among local workforces within Alaska communities.

Chairman Schultheis invited Marsh to present.

Marsh provided brief remarks echoing concerns put forth by Palmer related to preparation and expenses of ongoing COVID prevention in local workforce. Marsh noted start of sea cucumber season, ongoing geoduck fishery.

Chairman Schultheis invited Erickson to present.

Erickson noted slow start to Dungeness season. Noted slow response from China related to sea cucumber market. Noted strong sales of halibut and black cod.

Chairman Schultheis invited Enlow to present.

Enlow noted low returns on pollock. Echoed remarks made by Kimball and Palmer, citing ongoing concerns of COVID prevention and related costs. Enlow provided brief update on air transport related to moving workforce into and out of Dutch Harbor. Charter transport primary air travel with no current indications of return to commercial service at time of report.

Chair Schultheis invited Skaflestad to present.

Skaflestad echoed concerns expressed by fellow Board regarding COVID testing and costs.

II. Executive Session

Chairman Schultheis requested motion to enter into executive session.

Skaflestad moved to enter into Executive Session to discuss ASMI Species and Operational Committee Review and Appointments, and to discuss ASMI Physical Office Review. Enlow seconded the motion. All were in favor. Motion passed unanimously.

Marsh moved to return to Open Session. Vice Chairman Kimball seconded the motion. All were in favor. The motion passed unanimously.

Vice Chairman Kimball motioned to approve the committee assignments as read aloud by Executive Director Woodrow. Erickson seconded the motion. All were in favor.
